**a. Education & Events**

**1. Upcoming events**

Creative Kids' Christmas Market is November 30 at Virginia Cooperative Extension from 9 a.m. - 2 p.m. A canned good or \$2 entrance fee will benefit the Bedford Community Christmas Station.

**2. School Ag Programs Update**

Several students attended National at State Convention and competed successfully, earning approximately six American Degrees.

Ms. Tomlinson has the students engaged in a variety of activities.

A recent meeting regarding the County Fair was successful. The County staff and Board of Supervisors will vote on using the same grounds again next year. The Fair Board intends to find a suitable location for long-term use.

The FFA Chapters are selling citrus fruit and Liberty FFA is hosting a Christmas market.

**b. Marketing & Production**

Montvale's season has concluded, and a holiday market is planned for November 30<sup>th</sup>.

The Forest Market will be on site until November 23 from 9 a.m. to noon, with participation from over fifty vendors.

The Bedford Market will host evening Holiday Markets, on November 16, 9 a.m. - 1 p.m., and December 7, 5-9 p.m.

Ms. McIntyre will attend the Mid-Atlantic Farmers Market Conference.

Nine coyotes have been killed to date.

2023 - 710 deer were donated during the entire season

2023 - September 2 to November 5, a total of 131 deer were harvested, resulting in 3,954 pounds of meat.

2024 - September 7 to November 5, a total of 291 deer were harvested, resulting in 8,289 pounds of meat. Of these

291 deer, 190 were deer without antlers.

Media Squatch continues its partnership with the PR Board and will continue weekly podcasts through 2025.
